**URGENT NOTICE...You need to respond now.**

**The FMCSA (Federal Motor Carrier Safety Administration) UCRA (Unified Carrier Registration Agreement) is *now here* AND YOU MUST REGISTER.**

The UCRA replaces the former SSRS (Single State Registration System). However, this now includes:

- Motor Carriers,
- Motor Private Carriers,
- Brokers,
- Equipment Brokers,
- Inter-modal Carriers,
- Transporters of Agricultural Products,
- Leasing companies, and
- Freight Forwarders.

**In other words, if you have an MC or FF number, YOU MUST REGISTER...**
